In today's society, there are a multitude of stressors that result in individual or family crisis. You don't have to go through this alone; help is available. Behavioral health services provided by our network of providers can focus on the needs of children, adults, and/or families.

### Building Family Strengths

Behavioral health services provided by our network of providers emphasize family involvement in the treatment process. In many situations, the issues that are going on with a specific individual affects the entire family.

The services will be designed specifically to help you and your family define your collective strengths and simultaneously provide opportunities for the entire family to work on solutions for the problems that interfere with peace of mind and potentially jeopardize relationships. By utilizing strengths, setting goals and working together to reach them, the entire family takes ownership of both the issues and the solutions.

Active participation in the treatment process means that clients help determine the treatment interventions and when appointments are scheduled. When possible, our network of providers offer behavioral health services during evening and weekend hours. Services may also be available in the family home when clinically appropriate.
